

2011 “Guns and Gears” gun raffle official rules

- You must be 18 years old and a legal resident of the United States to purchase a ticket.
- Limit of 1000 tickets to be sold numbered from 0001 to 1000.
- There is no limit to the number of tickets one may purchase.
- Tickets are available for purchase through July 30th unless sold out before then.
- All proceeds benefit Electric City BMX a non-profit organization.
- Drawing will be held at Electric City BMX, 1200 21st Ave. So, Great Falls, MT at approximately 12:00pm noon on July 30th, 2011.
- You need not be present to win.
- Winners will be notified, using the name, address and phone number that the purchaser has written or requested to be on the ticket stub. In the event that Electric City BMX is unable to contact the winner it is the sole responsibility for the winning ticket holder to contact Electric City BMX to claim their prize. Prizes are not transferable; the person designated on the ticket must claim the prize. ALL PRIZES MUST BE CLAIMED AND TRANSFER COMPLETED WITHIN 30 DAYS OF THE SCHEDULED DATE THE TICKET IS DRAWN.
- By obtaining a ticket you attest that you are a law abiding citizen of good moral character, may legally possess the firearm(s) won, have intention of using the firearm(s) only in a legal and safe manner, and will or have already obtained instruction on the safe use and operation of the firearm(s) won.
- Unclaimed tickets will be redrawn if the winning ticket holder cannot be contacted or does not claim prize in 30 days.
- All Federal Bureau of Alcohol, Tobacco, and Firearms rules apply.
- All firearm transfers will be done through a Federal Firearms Licensed (FFL) dealer and all Federal, State and local laws apply, including the state laws for the legal residency of winning ticket holders.
- Winning ticket holders must make transfer through the Electric City BMX selected dealer, and in accordance with all applicable laws.
- Transfers will be done by Big R Stores, 4400 10th Ave. So., Great Falls, MT.
- In the event that the winner needs or wishes to have the firearm(s) won transferred to their local FFL dealer closer to their residence, shipping and any other additional costs involved with the transfer will be the responsibility of the winner and arrangements must be made with the Electric City BMX selected FFL dealer.
- Winners may be required to verify that ownership of the firearm(s) won is legal in their state, city or town, prior to taking possession of won prize(s).
- Electric City BMX makes no warranty of firearms; winners will deal directly with manufacturer if problem arises.
- Electric City BMX makes no claims of firearms suitability of purpose of firearms won.
- Electric City BMX limits any and all liability to purchase price of ticket purchased.
